Potassium Permanganate (7722-64-7), >99%

Section 4: **First Aid Measures**

Always seek professional medical attention after first aid measures are provided.

Eves: Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally. Skin: Immediately flush skin with excess water for 15 minutes while removing contaminated clothing.

Ingestion: Call Poison Control immediately. Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink.

Induce vomiting immediately.

Inhalation: Remove to fresh air. If not breathing, give artificial respiration.

Section 5: **Fire Fighting Measures**

Strong Oxidizer. When heated to decomposition, emits acrid fumes of manganese oxides and potassium hydroxide.

Protective equipment and precautions for firefighters: Use foam or dry chemical to extinguish fire. Firefighters should wear full fire fighting turn-out gear and respiratory protection (SCBA). Cool

container with water spray. Material is not sensitive to mechanical impact or static discharge.
