Copper(II) bromide (7789-45-9) 4.5% and Water (7732-18-5) 95.5%.

Light blue-green aqueous solution. Odorless.

Slightly toxic by ingestion. Mild tissue irritant. Avoid contact with body tissues and mucous membranes.

SECTION 4 — FIRST AID MEASURES
